on networking for supporting cognitive, social and intrapersonal issues of students with disabilities

Preamble

The Agreement on networking for supporting cognitive, social and intrapersonal issues of students with disabilities arranges all legal issues, structure and functioning of the Student Advisory Office for students with disabilities.

The agreement arranges relations and procedures between the Student Advisory Office for students with disabilities, Association of Youth with Disabilities of Montenegro, the University of Mediterranean, the University of Donja Gorica (hereinafter Participating institutions) and students with disabilities.

The agreement regulates relationships and procedures between the Student Advisory Office, the Association of Youth with Disabilities of Montenegro, University of Mediterranean, the University of Donja Gorica and students with disabilities (hereinafter referred to as: the partner institutions).

It is based upon documents created within the WP 4 of the SINC@HE Project, which include:

1. Rectors' charter- charter for support and inclusion of students with disabilities at higher education institutions in Montenegro;
2. University of Mediterranean's Senate Resolution on establishing Student Advisory Office for students with disabilities;
3. University of Donja Gorica's Senate Resolution on establishing Student Advisory Office for students with disabilities;
4. Association of Youth with Disabilities of Montenegro's resolution on establishing Student Advisory Office for students with disabilities;
5. Other general acts of University of Mediterranean, University of Donja Gorica and Association of Youth with Disabilities of Montenegro related to students with disabilities' rights on alternative solutions.
